1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

The Lake County Continuum of Care (LCCoC) has partnered with Adventist Health (AH) as our CoC's Coordinated Entry Operator and their Pathways HUB project. Our CoC's written CES policies and procedures describe the process by which persons will be prioritized for referrals to homelessness prevention services. The Pathways HUB is designed as a closed-loop referral system for community members with behavioral health needs and who are experiencing homelessness. By merging the two (2) projects together with custom integration Data Walk software from our HMIS to CCS, our CE process will become more effective and efficient by automating our CE process. This innovative process will extend our reach to those who may not seek to enter CE. All participants who entered the Pathways HUB are entered into HMIS and begin the CE process. All households enrolled in the CE project are assessed using Lake County CoC's primary Vulnerability Assessment Tool. This tool was designed by our CoC to be taken once unless additional circumstances are presented by the household or their assigned support staff serving the client. CoC's written policies and procedures describe the standardized assessment process, including the criteria used for uniform decision-making across access points and staff. Adventist Health conducts our CoC's Vulnerability assessment through HMIS, connects all participants with a Housing Navigator, and refers participants to the appropriate services not only within our geographical area but to outside entities that are able to provide more in-depth services if needed. Between CE and the Pathways HUB, they both act as wrap-around services for our most vulnerable population. Provider agencies not participating in the CE system will nonetheless be required to use the CE system to link their clients to the housing and services programs that are participating in CE. The Coordinated Entry Subcommittee will maintain and annually update a list of all resources that may be accessed through referrals from the CE system. This planning project will allow the CoC to continue to better serve our participants as they move through our homeless systems of care while honoring Housing First and offering other support services. The project will include a continuance of HMIS licenses for our nine (9) Access Points strategically located around our rural geographical area with California's largest natural lake in the center of our county.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Lake County Behavioral Health Services (LCBHS) is the Administrative Entity, Collaborative applicant, and HMSI Lead Agency for our CoC. As the Collaborative Applicant, and HMIS Lead Agency, the Lake County Behavioral Health Services department staff will immediately initiate these proposed planning activities by continuing to provide HMIS Licenses for our Access Points and the CES Operator. Our CoC Analyst/HMIS Administrator and CES Operator's program manager have already begun discussions with Social Solutions and CCS Healthcare about the Data Walk. Our CoC will continue to research the software companies that can create the Data Walk between HMIS and CCS, conduct a cost analysis, and view demos. Once our CoC has decided on a Data Walk software company, we will begin the contracting process and scheduling planning meetings with the entity. This process will include the building of the Data Walk, testing user training, and implementation.

Our CoC's management plan will include the continued partnership between our CoC's HMIS Lead Agency and our CoC's CES Lead Agency. This will include regular meetings between our HMIS Administrator and CES Operator, our HMIS custom report writer Web Intelligence reports from HMIS, and communication with our HMIS software, Pathways HUB software, and Bridge software. CES will continue with its current process with the added support of the Pathways HUB data. All information will be presented to our CoC's HMIS/CES Committee and CoC general and Executive committee meetings.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

This CoC is fairly new and has worked diligently to become a well-established. high-functioning CoC. We are still not functioning at the high level we need and expect. The requested funds will significantly assist towards the improvement of our local protocols and HUD compliance through the assistance in maintaining our CoC's HMIS and CES, which will then result in new CoC and ESG projects and their subsequent evaluation. All programs receiving referrals through CES, including CoC/ESG funded programs, must participate in Coordinated Entry as established by the CoC as the only referral source from which to consider filling vacancies in housing and/or services Our CoC has partnered with Adventist Health who has become the CES Operator. The bridge between HMIS and the Pathways HUB will provide the required program-level performance that has been formed to identify the framework that will identify a set of measurable goals by which to evaluate all projects participating in HMIS and CES; custom reporting will support the CES Operator's efforts including performance outcomes for all CoC and ESG-funded projects. Custom reporting is needed to support the CES Operator efforts and will encompass data quality timeliness standards, number served as compared to contract goals, identification of underserved populations as they compare to the general population, and other insights toward service improvement. The bridge between HMIS and the Pathways HUB will act not only as a safeguard to ensure there is no duplication of benefits but will increase the reach our CoC will have to all our community members experiencing homelessness.
