### 3. Public Comments:

- 3.1 Open for Public Comments 3 Minutes Each
  - 3.1.1 Wendy Manfred's Chief Probations Officers of CA, which consists of 59 different Probation Officers in the state. Each year we recognize individuals who

- work with people who are justice involved and who have made a huge impact in our community. This year Mary Wilson was nominated and chosen to receive this award. I wanted to thank Mary for everything she \does for us and all the people we work with. We appreciate you so much. Thank you, Mary, this is a well-deserved award.
- 3.1.2 12/18 from 4 to 7 PM is the Compassion in the Cold event at Hope Center. Every year around December 21st CoCs and homeless service providers are encouraged to hold a memorial for the National Persons Experiencing Homelessness to honor and remember the lives lost in the past year due to homelessness. It's a time for service providers to come together and recommit to ending homelessness. There will be a hot meal of chili, cornbread, and hot drinks. We are taking donations of jackets and blankets.
- 3.1.3 Derek Success Story One of our Builders in Workforce Development Career Fundamentals team struggled with many barriers and housing was one of them. He is in Hope Center. He has been growing by leaps and bounds over the last three months and is now housed. We received feedback from a company he is working under. He was given a perfect score. He is an excellent worker. We are recruiting for our next crew for the spring.
- 3.1.4 Bruno went to SoCo. Went on a tour of their juvenile justice center. Went to their CoC which is through their Human Services Department. I am opening up conversations with them to find out what they are doing, and what grant funding they are getting that we are not. How can we work together? Jessica Homes with Catholic Charities. They build a beautiful facility in Santa Rosa that takes up an entire block. They have an admin center to get people to where they need to be, a shelter, housing, and childcare for people to go to school, and workforce development so their children will be cared for. The numbers they were sharing were up to 2600 people.

#### 5. Presentations

- 5.1 HDAP Prevention and Diversion Program Malinda Lar
  - 5.1.1 CalWorks Housing Programs Housing Support Program CalWORKs eligible families who are homeless or at risk of homelessness for whom THA/PHA is not a solution may be referred to the Housing Support Program (HSP) to meet their family's housing needs. HSP is operated in partnership with North Coast Opportunities (NCO) under a "housing first" model. The referral to HSP is made by the CalWORKs Eligibility Specialist.
  - 5.1.2 Family Stabilization Program CalWORKs families where at least one parent is participating in Welfare-to-Work may be eligible for the Family Stabilization Program (FSP), which can provide a variety of flexible supports including housing assistance to deal with a crisis. The Employment & Training Worker handles the Welfare-to-Work case screens and assists the family with FSP if they are eligible.
  - 5.1.3 Diversion Services The county determines if you are eligible for diversion services. Diversion services are intended for individuals who: May benefit from these services and could avoid the need for monthly cash aid. Are eligible for cash aid. Need cash or non-cash assistance to address a current need or emergency. You can only receive diversion services at the time of application.

TANIF is CalWorks but TANIF is strict. I believe the clock is at 48 months now. With CalWorks you can receive benefits until your child is 18.

Pregnant Youth are eligible for CalWorks after 2 months of pregnancy.

Discussion on the CoCs prevention funding and how we can partner with DSS for prevention and diversion programs and other supports from Hope Center. Discussion on having the information in one spot for all homeless service providers to access for clients.

- 5.2 Supporting Bright Futures Sober Living House Angelique Cole
  - 5.2.1 I own properties and want to help people with my properties. My goal is to collaborate with the CoC and utilize my properties which typically struggle with housing. I have cultivated a network of Like-minded landlords.
  - 5.2.2 My approach is a shared housing model, that makes it affordable through grants, organizational funds, and private pay. I am working on ECM approval through CalAIM.
  - 5.2.3 Our first house is contracted with Lake County Probation. We provide a crucial steppingstone for those transitioning back into society. This will include providing resources, job placement, access to food and healthcare services, and pathways to permanent housing. This is a transitional housing model with stays of 3 to 12 months.
  - 5.2.4 This is a structured house with rules. Participants must be actively looking for work or working during the day. There is internet access to look online for job searching and applying for resources.
  - 5.2.5 Community connections resources in the house for them to get back on their feet. The success relies heavily on collaboration. I am actively looking for groups

- that would benefit most from the shared housing approach. This can include recovering addicts, the elderly, etc.
- 5.2.6 The first home is in Clearlake and can house 10 people. The second house is in process for SLE or elderly housing. We are exploring various funding sources to expand the program and house more people in need. I am hosting a grand opening soon. I will be sending out invitations.

  - 6.1.1 Data cleanup in the HUB, HMIS/CES projects are accurate. CCS contract about to be signed. Once the contract is signed, we will have a mass training.
- 6.2 Interfaith J Murdock Flyers
  - 6.2.1 We are finalizing the last step for the 2024 plan. We have flyers I will be handing out. We are developing a plan for the laundry services. The plan is for a community member will go to one of the laundry mats, purchase a card with \$5.00 load it with funding, and bring the card to the church and place it in the offering basket, the pastors will bring the card back to me, I will get it to the Hope Center, Restoration House or wherever so we keep the cards in circulation. We now have an email address, <a href="mailto:lakecountycares@gmail.com">lakecountycares@gmail.com</a>. Pastor Shannon is helping with a survey for 2025. We are trying to figure out how to better use our churches.
- 6.3 Are we getting this onto social media? If Melissa posts something on the website, it can be automatically posted to Facebook. Megan Morgan will be adding the resources brochure to the Behavioral Health website. Melissa met with Sage to discuss data and data cleanup.
- 6.4 Performance Review Holly Hana
  - 6.4.1 Reviewed RCS, no findings for the HOME SLE, there are findings in RCS shelter. I will meet with Melissa and Sage and come up with an action plan. HMIS data was missing.
- 6.5 Point in Time Count Shannon Kimbell-Auth Absent, Melissa reporting.
  - 6.5.1 Counting Us App questions presented. Requesting approval from the CoC. Questions reviewed with the CoC. Foster care and justice-involved questions changed to gather better data.
  - 6.5.2 Shannon met with the 7 local tribes to discuss gathering data. The Tribes request that we only ask about the 7 tribes. The request from the PIT count is to honor their wishes and only ask about the 7 local tribes and having one option as "other".
